The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

1.0 ARCHITECTURAL:

1.1 Specification:

1. Section 01 00 10 - General Instructions

.1 Clause 1.19.4

ADD MSK 1 and MSK 2 (attached) for clarification on the custom scaffolding and significant work access restrictions required to access the underside of the 5th floor slab. Shown are the existing mechanical ductwork and plumbing in the mechanical room directly below the 5th floor men's change room.

2. Section 09 30 13 – Ceramic Tiling

.1 DELETE Clause 2.1.1 and **ADD** new Clause 2.1.1 to read as follows:

Porcelain Floor tile Type **PT1**: 50 x 50 x 9 mm thick. Square edges. Integrally coloured throughout. Pattern, colour, texture and style as follows:

.1 One pattern, colour, texture, and style as selected by the Departmental Representative from manufacturer's standard, full, extended and custom range.

.2 Type 4, MR 1, frost resistant.

.3 Breaking strength to meet ASTM C648.

.4 Static Coefficient of Friction: ASTM C1028.

.1 Dry: 0.70

.2 Wet: 0.60

.5 Base: Install two stacked rows of floor tile PT1 for the base. Tiles to be laid up stack bond with base mortar joints to align with all tile joints above.

.6 Provide matching trims to suit application.

.2 DELETE Clause 2.3.1.1 and **ADD new** Clause 2.3.1.1 to read as follows:

Type **CT** (washroom and locker room walls): 75 x 152 x 6 mm thick. Pattern, colour, texture, and style as selected by the Departmental Representative from manufacturer's standard, full, extended and custom range.

.1 Type 1, MR 1, frost resistant.

.2 MOHS: 7.

.3 Laid up in stack bond pattern.

.1 DELETE Clause 2.1.1 and **ADD** new Clause 2.1.1 to read as follows:

- .3 Noise reduction coefficient (NRC) designation of 0.60 - 0.70.
- .4 Surface burning characteristics to ASTM E84 as follows: Class A.
 - .1 Flame spread rating: 25.
 - .2 Smoke developed: 50.
- .5 Surface texture: smooth.
- .6 Colour: white.
- .7 Sizes and styles: 610 x 1524 x 19mm. Square edge.

4. Section 10 21 20 – Solid Phenolic Shower and Dressing Partitions

- .1 **DELETE** Clause 2.2.4.5 and **ADD** new Clause 2.2.4.5 to read as follows:
Coat Hook: 50 x 50mm overall size with 40mm projection from wall. Flat face, vertical orientation of hook. Heavy duty, all welded construction. Satin stainless steel. 2 piece mounting bracket consisting of 1.2 mm thick stainless steel welded inside flange and 1.0 mm thick stainless steel wall plate. Stainless steel set screw. Quantity: 1 per shower stall.

5. Section 10 28 10 – Toilet and Bath Accessories

- .1 **DELETE** Clause 2.2.6 and **ADD** new Clause 2.2.6 to read as follows:
Coat Hook: solid stainless steel construction. 50 x 50 mm overall size with 40 mm projection from wall. Flat face, vertical orientation of hook. Heavy duty, all welded construction. 35 x 35 x 3.6 mm thick rectangular stainless steel cap welded to support arm. Satin stainless steel. 2 piece mounting bracket consisting of 1.2 mm thick stainless steel welded inside flange and 1.6 mm thick stainless steel wall plate. Stainless steel set screw.
- .2 **DELETE** Clause 3.2.7 and **ADD** new Clause 3.2.7 to read as follows:
Grab Bars: Two grab bars at one urinal. 2 at 610mm long mounted vertically at each side of urinal.
- .3 **DELETE** Clause 3.2.9 and **ADD** new Clause 3.2.9 to read as follows:
Robe Hook: Provide one in each toilet compartment.

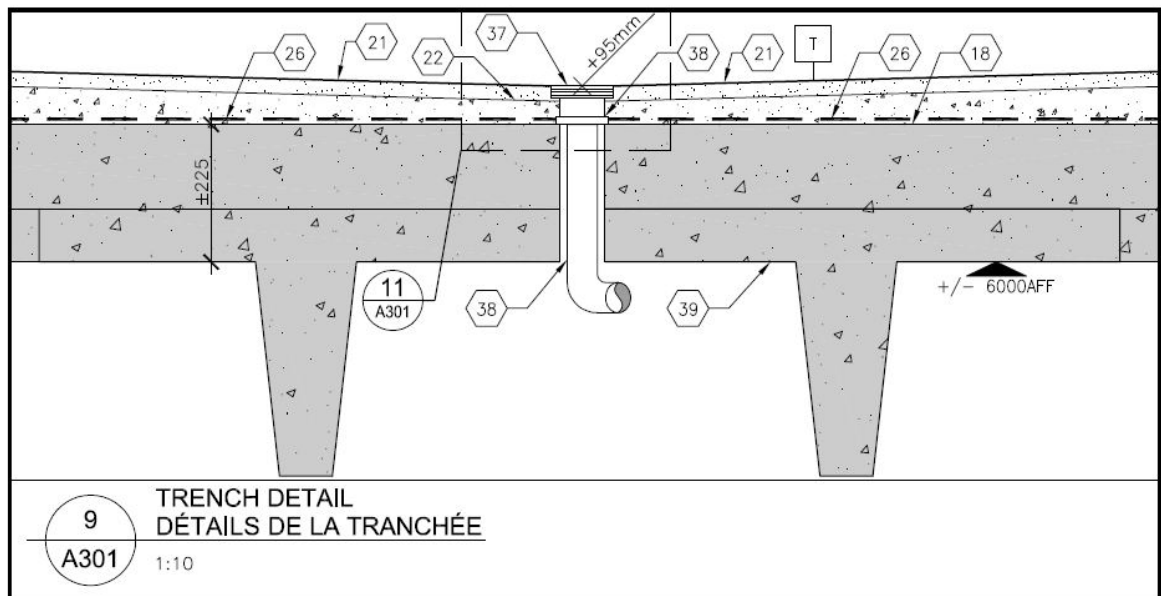

- .1 DELETE** General Note F and **ADD** new General Note F to read:
Deep scan or X-ray top and bottom of slab for any penetrations through floor, not limited to shower drains, floor drains, toilet drain, urinal drains, and lavatory drains. Ensure no re-bar is cut or compromised.
