Q1: A Nortec electric humidifier has been added to the equipment list, is there a desired scope for this, or just monthly inspections? Would inspections be required every month or just in the heating season?

A1: Maintenance is to be performed as per SW2.1.1 and the frequency of inspections for all of the inventory is to be as per SW3.1.; no exceptions.

Q2: Is this RFP based solely on low bid price?

A2: As per 4.2 Basis of selection, a bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.
