The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

## **QUESTIONS AND ANSWERS**

**Q1:** There is substantial reinforced concrete that is blended in with the existing armour rock. Is there a place Public Works have to dispose of this material?

**A1:** The concrete is to remain in place. The new revetment face is further seaward than the existing face- any concrete within this area is to be buried beneath the new construction.

**Q2:** How do we get paid for removal of old concrete?

**A2:** The old concrete is not to be removed.

**Q3:** Who is responsible for assessing the existing armour to see if it meets the type 2a armour specification? Is the out of spec armour paid for under backfill?

**A3:** The Departmental Representative will assess the existing armour.

**Q4:** Will section 01 11 55 1.15 Time of Completion be amended to correlate with the fisheries open Sept 01<sup>st</sup> to Oct 31?

**A4:** Construction works are to proceed in accordance with Addendum No. 1.

**Q5:** There seems to be a conflict between DFO permit item 9 "The beach fronting the spit is under constant wave action and has no vegetation" and page 2 of hpac-pa4-00033 page 2, "Access to the site should be kept to one identified access lane in order to protect riparian vegetation".

Can we work at the top of the new slope including the 10 meters of upland area (riparian area)?

**A5:** Work can be done from the top of the new slope.

**Q6:** Is the specification for armour and underlay based on weight?

**A6:** Specifications reference both nominal size in millimetres and mass in kilograms for armour and underlayer. Quality assurance testing will be based on actual measurements of material produced, and measurements will take precedence over weight.

**Q7:** What is the under run limit on item 8 before the contractor can submit a claim for additional costs (i.e. if materials are barged to site and we require more than 20% of any given item)?

**A7:** It is expected at this time that the quantities will remain fixed, and the extent of revetment armouring will lengthen or shorten to match the volume tendered. If there are quantity variations, these will be handled in accordance with contract general conditions, specifically Clause GC6.4.3.

**Q8:** Geotextile Spec. 31 32 19 01 item 3.2.4 – could you please clarify the spacing required along the seam? If the seam was 15 meters in length how many pins would be required?

**A8:** As specified under *Section 3.2 Installation*

**Q9:** Geotextile Spec. 31 32 19 01 item 2.1.2.4 burst strength. My suppliers are unable to find any fabric that can achieve the desired burst strength. Could you please verify the specification for burst strength?

**A9:** This requirement is unnecessary. See *Changes and Clarifications* below.
