Bidders are requested to communicate with the Contracting Authority **2 day(s)** before the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance form. Bidders who do not attend or send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid.

Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

QUESTION

The summary document with the site maps states the start date is April 1, 2013, but the tender is due April 17. Please explain.

ANSWER

The Invitation to Tender document takes precedence over the specification. The Invitation to Tender states in **Part 1 - GENERAL INFORMATION, 1. Requirement** :

The Service Contract is from award to March 31, 2014, with an option to renew for two additional one year periods.
