**Lot 1**

- Q1. Will the successful bidder receive mailing addresses for the 1350 properties?  
A1. Yes. As well, we will also provide, in most cases, a phone number and contact name.
- Q2. Is an estimate available of the percentage breakdown between urban and rural properties that require radon measurement?  
A2. All of the properties are in Ward 1 of Port Hope which is an urban area.

## ANNEX A - Statement of Work

Section 6 Scope of Work

- Q3. Page 7 of 24, 8th bullet -Please confirm that PHAI is requesting that the foils are to be returned to PHAI as opposed to being archived at the RSSI laboratory.  
A3. Foils are to be archived at RSSI.

Section 9 Contractor Qualifications

- Q4. Page 9 of 24, Items 2 and 5 - can it be assumed that the reference to QP under O. Reg. 153/04 includes a Qualified Person for Risk Assessment as well as ESA as referenced. See also the question related to Achievements of Key Personnel.  
A4. No, the QP must be only QPESA.
- Q5. Page 9 of 24, point 3 -are qualifications for financial/accounting services considered applicable to this project scope?  
A5. Annex A - Statement of Work, Page 9 of 24 at Contractors Qualifications Article 3. delete in its entirety.

Section 11 Schedule

- Q6. Page 10 of 24, - can you provide a target 'award of contract' date.  
A6. An award is to be made shortly after bid evaluation.

## ANNEX B - Basis of Payment

Section A General Tasks

- Q7. This section specifies the required format and supporting information for calculating the Estimated Total Price. Can you confirm that all project tasks (i.e. attending monthly meetings) are not expected to be scaled to a cost per estimated property units as illustrated in the sample table?  
A7. The costs for all tasks to complete the scope of work must be included in the unitary price.

## ANNEX E - Technical Evaluation

### Section 1.2 Specific Requirements for Proposal Format

- Q8. This section makes reference to "Licensing Information" being a part of the proposal content, could you clarify what licensing information should be included in the proposal?
- A8. The licensing information is not part of the maximum number of pages. Please refer to Annex E - Mandatory Technical Criteria.

### Section 2.1 Mandatory Technical Criteria

- Q9. Items 1 and 2 in Mandatory Requirements suggests that up to three project descriptions can be submitted to meet the mandatory requirements. Can you confirm that per Section 2.2.1, only the first two listed in the proposal will be considered for scoring, or will all three projects descriptions be used in the scoring process.
- A9. For meeting the mandatory criteria 3 projects must be submitted meeting the requirements of Section 2.1, items 1 and 2.  
For meeting the requirements of section 2.2.1, only two projects should be provided and will be scored. If more than two projects are submitted, only the first two projects will be scored.
- Q10. Items 3 indicates that the project team must include one person for each of the categories identified. Does this preclude a person from serving in more than one role and being scored separately in each.
- A10. No, this doesn't preclude a person from serving in more than one role. If a person is serving in more than one role, the demonstrated relevant experience in each role proposed must be clearly identified. Separate submissions for each proposed role may be required to demonstrate the relevant experience in the proposed role.
- Q11. Recognizing the PHAI has a communications team that effectively liaises with the community, can you clarify the expected role of the "communications specialist" on the project team. Is this person to provide strategic advice and direction on developing communications strategies at a high level (i.e. community outreach) or is their role more one of developing the communication tools used on a day-by-day basis (i.e. direct communications with households)?
- A11. Direct communications with households to fulfill the requirements of the SOW and liaising with PHAI communications staff as required.

### Section 2.2.4 Achievements of Key Personnel

- Q12. In this section education, certifications and professional accreditation includes qualification as Qualified Person ESA under O. Reg. 153/04. Can you please confirm that a QPRA serves as an equivalent level of qualification as it is our experience that QPRAs have specific training and experience in conducting and evaluating the results of exposure assessments, which often include the results of indoor air surveys. Section 6 of Reg. 153/04 requires QPRAs to have a specific combination of education and experience as it relates to environmental site assessments and risk assessment. Under O. Reg. 153/04 Risk assessments, which include an evaluation of human health risk must be completed under the supervision of a QPRA.
- A12. The QP must be a QPESA.
