INVITATION TO PRE-QUALIFY

CONVERSION OF MILITARY VEHICLES TO COMMEMORATIVE MONUMENTS

1. GENERAL

- 1.1 The Department of National Defence (DND), Director of Disposal, Sales, Loans and Artifacts (DDSAL) has a requirement for the provision of labour, material, tools, products, storage space, transportation and equipment necessary to transport military vehicles from 25 Canadian Forces Supply Depot, Montreal, Quebec to the Contractor's facility, convert them into Commemorative Monuments and deliver them to their final destination.
- 1.2 The services are required for a period of two (2) years with the irrevocable option for extension of up to two (2) additional one-year periods.

2. BACKGROUND

- 2.1 The Canadian Forces currently has thirty-nine (39) military vehicles (quantities: 1 M113A2, 28 M109s, 6 C1 Howitzers, 3 Cougars and 1 Husky) that are out of commission and have been declared surplus. The objective is to remove the existing residual, unserviceable materiel and carry out specific work in order to convert each of these vehicles into a commemorative monument on an as-and-when-required basis. Other vehicles, like the Grizzly, are also scheduled for conversion; however, none has been declared surplus at this time.

3. PURPOSE OF THE INVITATION TO PRE-QUALIFY

- 3.1 The purpose of this INVITATION TO PRE-QUALIFY is to communicate the Canadian Forces (CF) requirements and to advise Industry that the Military Vehicles are of U.S. origin and contain Controlled Goods. In order to access ITAR-Controlled Technical Data, the names of entities must be vetted through the U.S. Department of Defence Trade Controls (DDTC) and must also be registered in the Canadian Goods Registration Program (CGRP).

As such, PWGSC is seeking the names of potential bidders who have an interest in the conversion of Military Vehicles into Monuments. To be pre-qualified, Respondents must:

- a. pass the US DoD vetting procedures. It should be noted that once the names are submitted to the US DoD, the process can take up to three (3) months; and
- b. be registered in the Canadian Controlled Goods Registration Program (CGRP).

4. **CONSTRAINTS**

- 4.1 The Contractor's facility, where the conversion will be performed, **must** be located within a 300-kilometer perimeter from the Longue-Pointe Military Base, 25 Canadian Forces Supply Depot, 6363 Notre-Dame Street East, Montréal, Québec to allow the Technical Authority (TA) and the Quality Assurance Representative (QAR) regular access to the site where the work will be performed. The relatively close proximity is also required to limit the risk of having Controlled Goods system on the road for a long period of time.

5. **PROCUREMENT MILESTONES**

- 5.1. In providing responses the following schedule should be utilized as a baseline (this schedule is an estimate only):

6. **REQUESTED INFORMATION**

Respondents are to utilize the Form attached as ANNEX "A".

Information required are:

- name and address of firm (for US DoD verification); and
- Indicate whether or not the firm is registered in the CCGRP by checking off / circling the "Yes" or "No" field.

Only potential bidders who are successfully vetted by the US DoD and registered in the CGRP will be invited to bid in the Solicitation phase.

- 7.1. All enquiries, clarification requests and other communications related to this Invitation shall be directed in writing only to the Public Works and Government Services Canada (PWGSC) Contracting Authority.
- 7.2. Interested suppliers who intend to respond to this Invitation are requested to advise PWGSC *by e-mail* so that questions and answers, clarification or changes may be promulgated if required.
