This amendment is raised to answer questions that were received from a potential bidder:

Question 4.

The Pickerel Frog, Brassy Minnow, Bald Eagle, Silver-haired Bat, Hoary Bat, Red Bat, and Cougar are not on Schedule 1 of the Species at Risk Act. Could you please explain why they are referred to that way in the RFP?

Response 4.

The federal government also respects the designation of provincially listed species. The aforementioned species are currently considered "likely to be threatened or vulnerable" in the province of Québec. For that reason, the technical authority wishes to evaluate the potential presence of these SAR and/or their habitat to ensure that a management plan may be established if their presence is confirmed during the Phase II study.

Question 5.

Is Northern Watersnake (not an SAR) referring to the subspecies Lake Erie Watersnake (which is an SAR)?

Response 5.

No. The Northern Watersnake (*Nerodia sipedon*) is a species currently considered "likely to be threatened or vulnerable" in the province of Québec.
