2. Request for clarification:

Question 1:

Is the experience of subcontractors can be considered for the point rated technical criteria of section 1 "Company Experience"?

Answer 1:

No, by Company Experience we consider the experience of the company which has signed and submitted the bid. In the cas of a Joint Venture, the evaluation team will consider the experience of all the parties involved in the Joint Venture.

Question 2:

For the point rated technical criteria of section 3.4 "Proposed resource for the Analyst labour category", is it possible to only consider the experience of the resource with the greatest experience?

Answer 2:

As it is already mentioned in the point rated technical criteria table, under section 3 "Proposed Resources (per labour category)" each resource will be evaluated individually. The overall scores obtained by each resource in the given category will be added and then divided by the number of resources available to obtain an average. The average will be the rating assigned to the bidder.

To be included in the contract in a labour category, the proposed resource must get the minimum score for the labour category to which it is proposed. Also, if a resource does not get the minimum score, his score will still be used for the average calculation.
