**AMENDMENT 002**  
**REQUEST FOR INFORMATION (RFI) REGARDING**  
**REAL PROPERTY 1 (RP-1) - PROPERTY MANAGEMENT AND PROJECT**  
**DELIVERY SERVICES**  
**(FORMERLY KNOWN AS ALTERNATIVE FORMS OF DELIVERY)**  
**FOR PUBLIC WORKS AND GOVERNMENT SERVICES CANADA**

**THIS AMENDMENT HAS BEEN RAISED TO EFFECT THE FOLLOWING CHANGES:**

**Phase 2:** PWGSC has determined that there will be more than one RP-1 contract and more than one winning RP-1 bidder. PWGSC is requesting a consultation with senior executives from companies that may be interested in submitting a proposal for the RP-1 requirement. The consultation will be in a group setting with Assistant Deputy Ministers of PWGSC and is expected to take place in the National Capital Area the week of December 10, 2012.

We are seeking potential bidders' innovative solutions to the challenge of how to divide portfolios while ensuring more than one successful service provider (size, type and number of portfolios). Thus, we are seeking potential bidders' feedback on possible strategies to divide the Work into more than one contract as well as looking for possible selection methodologies to ensure different service providers while allowing Canada to obtain best value and overall service.

In addition, we are seeking potential bidders' feedback on the duration of the future RP-1 contracts. We are seeking feedback on the length of the initial contract period as well as the length and number of any potential option periods in order to achieve best value for the Crown.

PWGSC intends to analyze potential bidders' feedback along with Departmental requirements in order to finalize the number and type of portfolios/contracts to be solicited.

Volumetric data will be provided Thursday November 29th as an amendment to the RFI to assist potential bidders in preparing for the consultation. The inclusion of this data in this RFI will be provided purely for informational purposes and does not represent a commitment by Canada that Canada's future usage will be consistent with this data.

Those companies that wish to participate in this consultation should advise via e-mail to **Biensimmobiliers1.RealProperty1@tpsgc-pwgsc.gc.ca**. In order to allow PWGSC to establish the schedule for consultation, respondents are requested to submit their interest to participate by **Friday, November 30, 2012 by 14h00** to the Contracting

Authority and provide a list of the senior individuals from their company who would be attending (limit of two per company). PWGSC will advise in due course on the detailed consultation schedule and location. Note that consideration is being given to establishing a videoconferencing option for attendance at this consultation.
