Amendment No. 002 is being issued to provide answers to bidders questions received to date concerning the Request for Proposal (RFP) document.

Questions and Answers

- Q1. Lunch: there is no lunch schedule for the Saturday, March 23, 2013.
- a. Are your delegates on their own for lunch? If they are, how much time do they have for lunch?
 - b. What is their per diem for that meal?
 - c. Will they all be eating at once? Or the group is off premises for the lunch period?
- A1.
- a. Lunch will be provided by the Department of National Defence (DND). They will have 45 minutes on Saturday and 30 minutes on Sunday.
 - b. Cost of DND meals are \$8.64 per person.
 - c. The group will be eating together at the same time. Preferably in the banquet room; however, if the hotel does not allow outside food in their meeting rooms, then they will consume their meal in their personal rooms.
- Q2. Breakfast: Will the group be eating all at once? Or they come down at their leisure?
- A2. The group will be eating all at the same time. Timing is detailed in the RFP document.
- Q3. From previous years itinerary, is there an agenda as for the timing of spaces, so that the hotel can try to keep costs as low as possible and re-use meeting rooms if possible.
- A3. All timings are detailed in the RFP document (0800 hrs Friday until 1800 hrs Sunday).

All other terms and conditions remain unchanged.
