As part of the online DCC, Suppliers will have a Solicitation Dashboard that will provide Supplier's information on PWGSC's Professional Services Standing Offers and Supply Arrangements that are anticipated to be issued.

Once a solicitation appears under "Open Solicitations" under the Solicitation Dashboard, Suppliers will then be able to start preparing their response. Once the solicitation is posted, suppliers should enrol in the Data Collection Component at any time and are encouraged to do it as soon as the solicitation is under "Open Solicitation". Your response can be changed anytime until the date and time of bid closing.
