AMENDMENT 010

The purpose of this amendment is to respond to bidder questions and amend the following:

QUESTION 11: in PART 3 - BID PREPARATION INSTRUCTIONS 1. Bid Preparation Instructions:

“Canada requests that bidders follow the format instructions described below in the preparation of their bid:

(a) use 8.5 x 11 inch (216 mm x 279 mm) paper”

Do we use 8.5 x 11 inch (216 mm x 279 mm) paper for the test document?

ANSWER 11:

No. Bidders must use 8.5 x 11 inch (216 mm x 279 mm) paper for their submitted bid.

The correct format to use for the printed test sample (test document) is 8 1/8” x 9 3/4”. Bidders must centre the text left to right.

QUESTION 12: In Annex C:

From the electronic file, Bidders must produce (complete the typesetting/page formatting and page layout for page size 8 1/8” x 9 3/4” of the provided document) and submit as part of their bid, a final printed Test sample of the required file, in the same format (including, but not limited to, all body text, head notes, foot notes, rules, folios, margin numbers, font and underlining styles, type sizes, capitalization, typesetting/page formatting and page layout etc...) as the sample copy from a previous production. In the rated criteria:

I. Type sizes and type face (fonts) to match:

Times New Roman - 10.5 for reasons/motifs (or Body Text/corps du texte)

Times New Roman - 9.5 for headnotes/sommaire and block quotations/citations en retrait

Should the test sample use the type sizes and type face (fonts) found in the sample or should the test sample use the type sizes and type face (fonts) as specified in the rated criteria (I.)?

ANSWER 12: Bidders must use the type sizes and type face (fonts) as specified in the rated criteria and Annex A – A.2.4.1 Typesetting and page formatting/page layout for their test document:

Times New Roman - 10.5 for reasons/motifs (or Body Text/corps du texte)

Times New Roman - 9.5 for headnotes/sommaire and block quotations/citations en retrait
