QUESTIONS and ANSWERS

Question 12:

Could you please clarify the client may consider reducing the word count under R2.2 for Senior resources. While providing samples of briefing notes to Director and above in a Government of Canada client (including Crowns and Agencies) will demonstrate experience and capabilities, having a minimum count of 1000 words in a "Briefing Note" to senior management does in fact look for a rather large briefing. Would the client consider reducing the minimum word count to say 500 on this Rated requirement as provision of a sample briefing note will in fact demonstrate the same capabilities and experience as a 1000 word minimum?

Answer 12:

We will not be changing the word count.

Question 13:

For the purposes of M2 and M3 for Senior Communications consultants, would experience in addition to experience in Government of Canada (including crowns and agencies) with an International Organization for which Canada is a contributing member in funding and partnership such as Organisation for Economic Co-operation and Development (OECD) or the World Bank qualify?

Answer 13:

We will not be changing the Mandatory Technical Criteria for M2 or M3.

Question 14:

As we are still awaiting a response to our question placed February 16 which has a very delaying influence on a vendor's ability to recruit and bid qualified resources, we request that the closing date of this RFP be extended to March 10, 2012.
