Provide new 45,460 L two (2) compartment double wall AST - one (1) 36,368 litre and one (1) 9,092 litre compartment - and piping to connect to existing system. Existing temporary 9,092 litre fuel oil tank to be removed from service and disposed. All temporary above ground piping and permanent underground piping to be removed from service and disposed."
2. Reference Section 23 56 13 - Oil Storage Tanks - Abovegrade .1 In the Specifications, remove section 23 56 13 and replace with revised section 23 56 13, attached herewith.
