2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted **by electronic mail to PWGSC will not be accepted.**

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than three (3) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in New Brunswick.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. PART 5 - CERTIFICATIONS

Bidders must provide the required certifications to be awarded a contract. Canada will declare a bid non-responsive if the required certifications are not completed and submitted as requested.

Compliance with the certifications bidders provide to Canada is subject to verification by Canada during the bid evaluation period (before award of a contract) and after award of a contract. 1.2 Former Public Servant Certification

6.4 Minimum Work Guarantee - All the Work - Task Authorizations

1. In this clause,

 "Maximum Contract Value" means the amount specified in the "Limitation of Expenditure" clause set out in the Contract; and

 "Minimum Contract Value" means 20% of the Maximum Contract Value.
2. Canada's obligation under the Contract is to request Work in the amount of the Minimum Contract Value or, at Canada's option, to pay the Contractor at the end of the Contract in accordance with paragraph 3. In consideration of such obligation, the Contractor agrees to stand in readiness throughout the Contract period to perform the Work described in the Contract. Canada's maximum liability for work performed under the Contract must not exceed the Maximum Contract Value, unless an increase is authorized in writing by the Contracting Authority.

ANNEX A**STATEMENT OF WORK****CONTEXT**

Providing bulk propane and reservoirs as described below on an "as and when requested" basis. All required services would be delivered into different locations In Canadian Forces Base Gagetowns' areas in New-Brunswick for the period beginning April 13th, 2012 to May 14th, 2012. Services are required for 5 Canadian Mechanized Brigade Group Units from Valcartier Garrison.

DESCRIPTION

Providing via rental, 500 gallon capacity reservoirs including tubes and all necessary attachments to hook on all mobile kitchens (Kitchen Trailers) located in different areas mentioned below.

Providing the required bulk propane to refill all 500 gallon tanks (approximately 1,300 litres capacity) rented through the supplier as well as all 100 lbs cylinders (approximately 90 litres) that DND would possess on site.

Supplier will install all tanks in a secure manner, maintain and remove tanks at the end of the leasing period.

Supplier also **MUST** hold all relevant licenses for the required services in accordance with the *Boiler and Pressure Vessel Act (New Brunswick Regulation 84-176)*. Proof of such licenses **MUST** accompany bidder's proposal.
