1. Questions and answers 1 and 2

Question.1 It is mentioned that proof is required of 5 deliveries in the region in the past 6 months. Would you consider having the proof in the past 3 years as opposed to the past 6 months?

Answer.1 No, only trainings that have taken place in the past six months from the request for proposal closing date will be considered. Refer to the mandatory technical criterion 1.1.1(C), at Part 4 - Evaluation procedures and basis of selection of the Request For a Standing Offer.

Question.2 Is proof of 5 deliveries required per region or would the 5 deliveries be sufficient for the entire RMSO response?

Answer.2 Regarding the mandatory technical criterion 1.1.1(C), at Part 4 - Evaluation procedures and basis of selection of the Request For a Standing Offer, the total number of 5 executed contracts must be provided for each sector quoted. Therefore, providing less than 5 executed contracts proof, for a sector quoted, will result in the dismissal of the bid.
