## Amendment No. 003

This amendment is being raised to: 1) provide responses to Requests for Clarification; 2) make revisions to the Appendix A - Annex AA section of the RFSO.

### 1. Requests for Clarification

**Q1:** Item 2.2 Specific Requirements for Proposal Format indicates a number of requirements that are required as part of the proposal but not counted as part of the 35 page limit. All of the 3.1 Mandatory Requirements appear to be excluded from the page count with the exception of item 3.1.2 Licensing, Certification or Authorization. Does 3.1.2 count towards the 35 page limit?

**A1:** No.

**Q2:** TP 10 Disbursements – Sentence 2 indicates that travel time is to be included in the ‘fees required to deliver consultant services’ and will not be paid as a disbursement. CF-1 Fee Arrangement(s) for Services indicates two methods for calculating the fees for services, both of which are a function of the submitted hourly rates. Will travel time be included in the hours used to calculate the fees or does travel time need to be accounted for in the rate itself?

**A2:** Travel time to be included in the hours used to calculate the fees, for Services identified in a Call-up.

**Q3:** If travel time in the above question, is included in the hours used to calculate the fees, then will the travel time be determined similar to the calculation for mileage?

**A3:** Travel time to be calculated similar to the calculation for mileage.
