At 2. Basis of Selection,

DELETE:

The lowest responsive bid meeting the mandatory technical criteria will be assigned a contract for 50% of the funds, the 2nd lowest responsive bid meeting the mandatory technical criteria will be assigned a contract for 30% of the funds and the 3rd lowest responsive bid meeting the mandatory technical criteria will be assigned a contract for 20% of the funds. If there are only two (2) responsive bids, the lowest responsive bid meeting the mandatory technical criteria will be assigned a contract for 60% of the funds, the 2nd lowest responsive bid meeting the mandatory technical criteria will be assigned a contract for 40% of the funds. If there is only one (1) responsive bid received, 100% of the funds will be assigned to that contract.
