This amendment 001 is raised to answer the following questions:

Question 1 : Can you expand on what is meant by Inspection Points as referred to on Page 10 of 24 para 1.3.2.3, page 24 of 24 para 9.1 and page G-1/1 Annex G?

Due to their size, products of this nature are usually inspected at source. Is the Crown requesting that seven distinct inspection facilities be established? If so, this would greatly increase the shipping costs as product would have to be shipped to the inspection point, await inspect by the Technical Authority and then be trans-shipped to the final destination.

Answer 1 : No. There does not need to be seven distinct inspection facilities. Supplier would indicate the seven inspection points as the one inspection point.

Question 2 : Ref "DL 0976732-1"

This package calls up drawing # 0976732 in which items # 2 and 3 are identified as part # A7077L and A10914 from vendor 03670 Tyco Fire Product. Contact with this vendor indicates that this part # is not recognized by them.

Answer 2 : P/N A7077L is correct. It is recognized by their affiliate company Ansul who has a Canadian representative in Canada, Levitt Safety (Vendor 35481), Tel. 613-225-9550.
