1. Questions and answers 3 and 4

Question.3 Regarding the security requirement, are the conditions to be met by the solicitation closing date?

Answer.3 No. As specified at article 1 - Security requirement of Part 6 - Security and financial requirements, the security conditions must be met before award of contract or standing offer, not at the solicitation closing date. However, bidders are reminded to obtain the required security clearance promptly. Any delay in the award of a contract to allow the successful bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority.

Question.4 Regarding the security requirement, where do we get the forms to be filled?

Answer.4 As specified in the Request for a standing offer, consult the "Security Requirements for PWGSC Bid Solicitations - Instructions for Bidders" (<http://www.tpsgc-pwgsc.gc.ca/app-acq/lc-pl/lc-pl-eng.html#a31>) document on the Departmental Standard Procurement Documents Web site.

Here is a part of it:

"Bidders and subcontractors that currently do not meet any of the security requirements identified in the PWGSC bid solicitation should initiate the security screening process immediately, as outlined below:

1. Bidders (including any subcontractors, if applicable) that are not registered in the Industrial Security Program (ISP) of PWGSC's Canadian Industrial Security Directorate (CISD) must ask to be registered in the ISP. Bidders should submit the request by e-mail to the Contracting Authority named in the PWGSC bid solicitation. The request must include the following information:
