Description of requirement

The Project Delivery Office' (PDO) role, under the PWGSC Chief Information Officer (CIO), is to support the delivery of PWGSC major IT-enabled projects. The PDO has a requirement for the services of a Technology Architect - Level 3 to support the upcoming releases of the Government of Canada Pension Modernization and the Government of Canada Pay Modernization Projects.

The Technology Architect, Level 3 will assess and define all aspects of technical solutions, including infrastructure, application, security, service levels, etc. for both the Pension and Pay Modernization projects and assess and define the integration between the two projects.
