“3.1 The subjects indicated in Canada Labour Code Part XVI, Schedule V, item 2 – Standard first aid shall form part of the course content. (See link below). The course content must also include the most recent cardiopulmonary resuscitation (CPR) protocols from the Heart and Stroke Foundation of Canada entitled “2010 Guidelines for CPR and Emergency Cardiovascular Care.” (See link below).

“Mandatory Criteria #3

The proposed instructors must provide a copy of their resume, have at least two (2) years of experience as First Aid/ CPR instructors, and have taught **First Aid/CPR training** to at least one police agency in the past two (2) years.”
