This amendment is raised to answer questions asked by bidders;

Question 1:

In section 7.2.2, in the event where licensed SW (i.e. EDA tools) purchased by the bidder specifically for this project cannot be transferred to CSA, should the bid include the cost for an additional license for CSA in the event they will be required by CSA to use the prototype?

Answer 1:

Any software purchased specifically for the project must be transferred to the CSA. The bidder should not purchase software that cannot be transferred. Refer to <https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/all-4003-para-04>. The intent of SACC 4003 is for software components that are part of the technical solution that CSA can use without restriction.

Question 2:

In section 7.2.2, In the event where licensed SW (i.e. EDA tools) already owned and maintained by bidder are used in this project and the Bidder will continue to own and maintain them after the project, should the bidder add the cost for additional licenses for CSA in the event they will be required by CSA to use the prototype?

Answer 2:

CSA does not need EDA tools that have been used to develop drawings, plans, schematics, models etc., as they are typically provided non native common formats such as word, pdf, html, etc.

Question 3:

Section 3A.6.4 - Should we complete or not the sections that will NOT be used as a proposal evaluation criterion?

Answer 3:

Yes, complete all sections.

Question 4:

In section 4A.2, the bidder is requested to provide substantiation (supporting evidence), which should be submitted as an appendix to their Section I (see section 3A.8.1). The sections listed in section 3A.8.1 (a through d) do not include a section for substantiation. Should the bidder add an

additional section in section 3A.8.1 to include the Substantiation tables like the example in Table 4A.2 ?

Answer 4:

Yes add a section

Question 5:

In section 3.1, it is mentioned that the bid should use a numbering system that corresponds to the bid solicitation. Just as a clarification, should we use Section 3A.3 for the Executive Summary or just Section 3 ?

Answer 5:

Although part 3, section 3.1 item j) refers to a numbering systems, the detailed instructions for bid preparation are in Attachment 1 to part 3, section 3A.1. This same section imposes the content for the bid and it's numbering. Here are some examples:
