Amendment No. 001 is being issued to include the information presented to bidders at the mandatory site visit and to provide answers to questions received.

A mandatory site visit was conducted at 10:00 hrs, 24 May 2013, at Contracts Section, Room 235, Base Construction Engineering, CFB Borden, Borden, Ontario for Requirement W0113-120282/A Ice Plant Maintenance.

The following information was presented to the bidders at the site visit:

Normal building working hours are from 08:00 to 15:30 hrs, Monday to Friday excluding any holidays.

John McTaggart, is the Project Authority (PA) for this project, however, other Contracts Inspectors may also be performing inspections as required.

The building has normal security requirements, which includes letting the building maintenance personnel know you are on site, as well as letting the PA know you are on site.

As the machine room contains refrigerant, keys will need to be obtained from the PA.

Any repairs or installations requiring use of installation instructions or listed components, must not be covered or concealed until inspected.

Only one original manufacturer's listed products or approved alternatives are to be used on the systems.

All Federal, Provincial, Industry and Base Safety Regulations must be followed.

All service reports and compliance certificates are to be issued in paper.

Base property traffic regulations were explained.

Base Borden uses a specific Ozone Depletion Prevention (ODP) form and it must be filled out and given to the Project Authority before completion of the job.

The attendance site visit register must be signed at the end of the visit, to be deemed as having attended the visit.

Any questions during the solicitation period must be directed only to PWGSC.

After award of contract, questions or clarifications shall be directed only to the PA.

Bidders were allowed time for the review of drawings followed by a tour of the site visit.

QUESTIONS AND ANSWERS:

Q1. There is a requirement that the contractor's mechanic's have normal industry certificates such as fall arrest or confined space entry training. Do the contractors have to include copies of this certification in their bids?

A1. Bidders must refer to the Request for Proposal, Part 4, Evaluation Procedures and Basis of Selection, Article 1.1.1. Mandatory Technical Criteria, which details the certificates that must be provided with the bid at time of bid closing.
