- 1.1 Interpretation of documents. .1 The term Engineer shall designate the DND Engineer or his designated representative.
- 1.2 Site .1 Work will be carry out in divers building own by department of National Defence located at 3 Wing Bagotville. The Contractor shall contact the representative of DND.

- 1.3 Scope of the work .1 Provide the personnel, the material and the equipment required for the complete work execution describe in this present technical Specification document;
- .2 Before beginning any work on request, wait for the DND authorized representative at Bagotville to give written authorization or verbal authorization:
- .1 Extractor hood and filters monthly cleaning;
- .2 Extractor hood, filters and air evacuator duct bi-annual cleaning; and
- .3 Annex A of present document describe de frequency, the building list and equipments that needs to be cleaned.
- 1.4 Regulations .1 Overloads: We must not impose to leaf a load that might compromise the security or cause a deformation to any parties.
- 1.5 Quality of work .1 Perform the work using best practices at the complete satisfaction of the representative of DND; and
- .2 In the event than an inconsistency, contradiction, impossibility or an unforeseen situation should arise in the course of the work; the Contractor will stop work immediately and notify the Engineer or his representative.

PART 3 – Execution

- 3.1 Information .1 The work described in para. 1.3.2 of the present technical specifications will be executed in accordance with the latest recommendations or user and care manuals for each products. Procurement of required manuals will be at the contractor's expense.
- 3.2 Extractor hoods cleaning .1 Extractor hoods and accessories cleaning (electric pipe, light, etc) including deteriorated or damage filters replacement by new filters. Filters will be at contractor expense;
- .2 Cleaning process must not live any trace of grease, dust or any other trace of dirtiness on all exterior and interior surfaces. The clean up must be at Fire chief and engineer representative satisfaction.
- 3.3 Complete clean up .1 Include all task of section 3.2;
- .2 Extractor hood and duct must be clean with cleaning product specified in section 2.1 and a steam machine for duct interior; and
- .3 Cleaning process must not live any trace of grease, dust or any other trace of dirtiness on all exterior and interior surfaces. The clean up must be at Fire chief and engineer representative satisfaction.

PART 4 – Administration

- 4.1 Schedule .1 contractor must inform engineer before monthly inspection and each time that work is done on base;
- .2 Work execution program must be submitted to the engineer and establish in a way that it interfere as less as possible with regular user activity inside occupied room;
- .3 Contractor must communicate with each building representatives to establish a appropriate schedule with them; and
- .4 Dates and timing will be established in advance and will not be change in any considerations with out engineer authorization.
- 4.2 Billing .1 Invoice must be send at indicated address in section 1.21 and the number 13CS30 and the requisition number given by the contract section must be on invoice.
