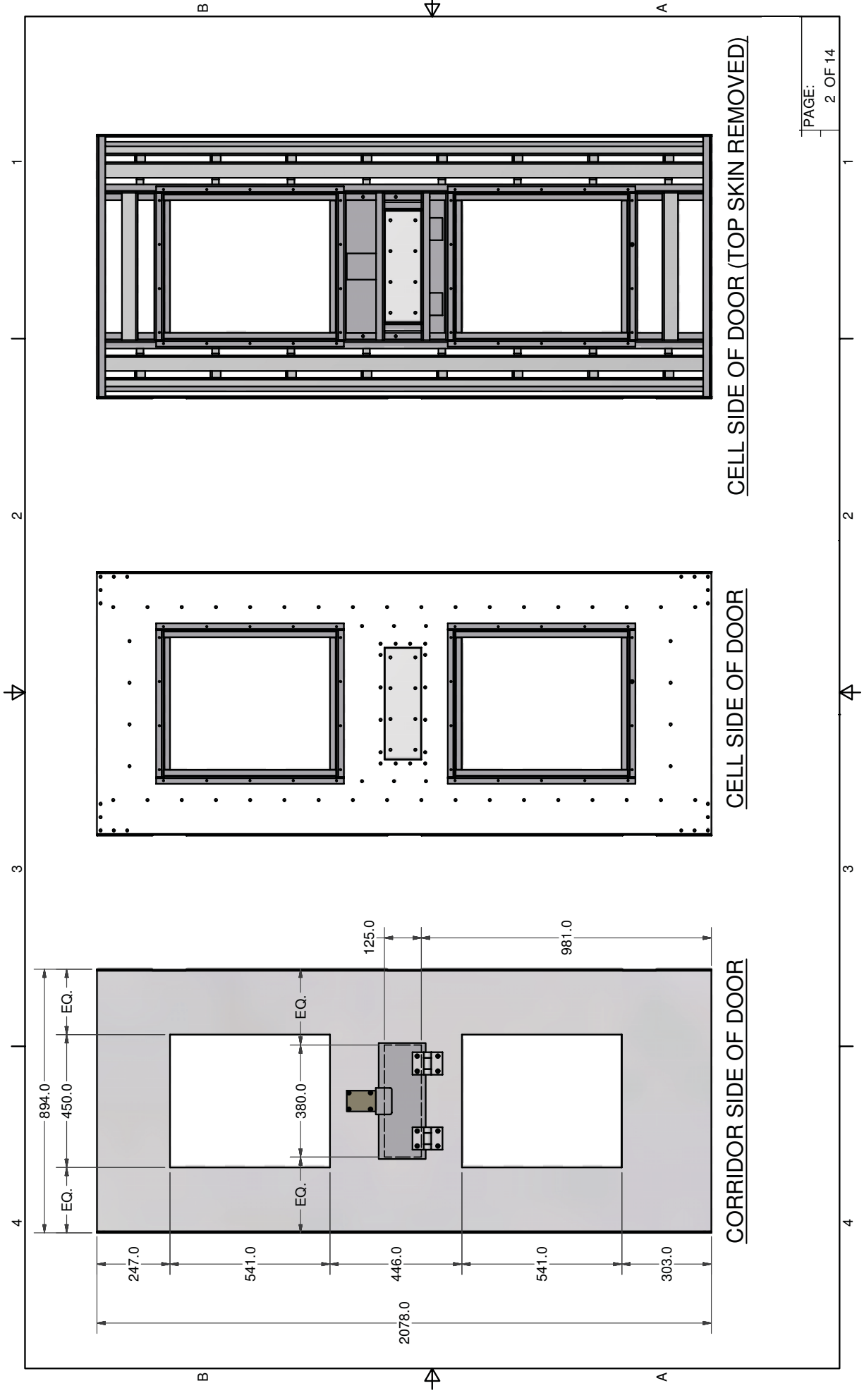

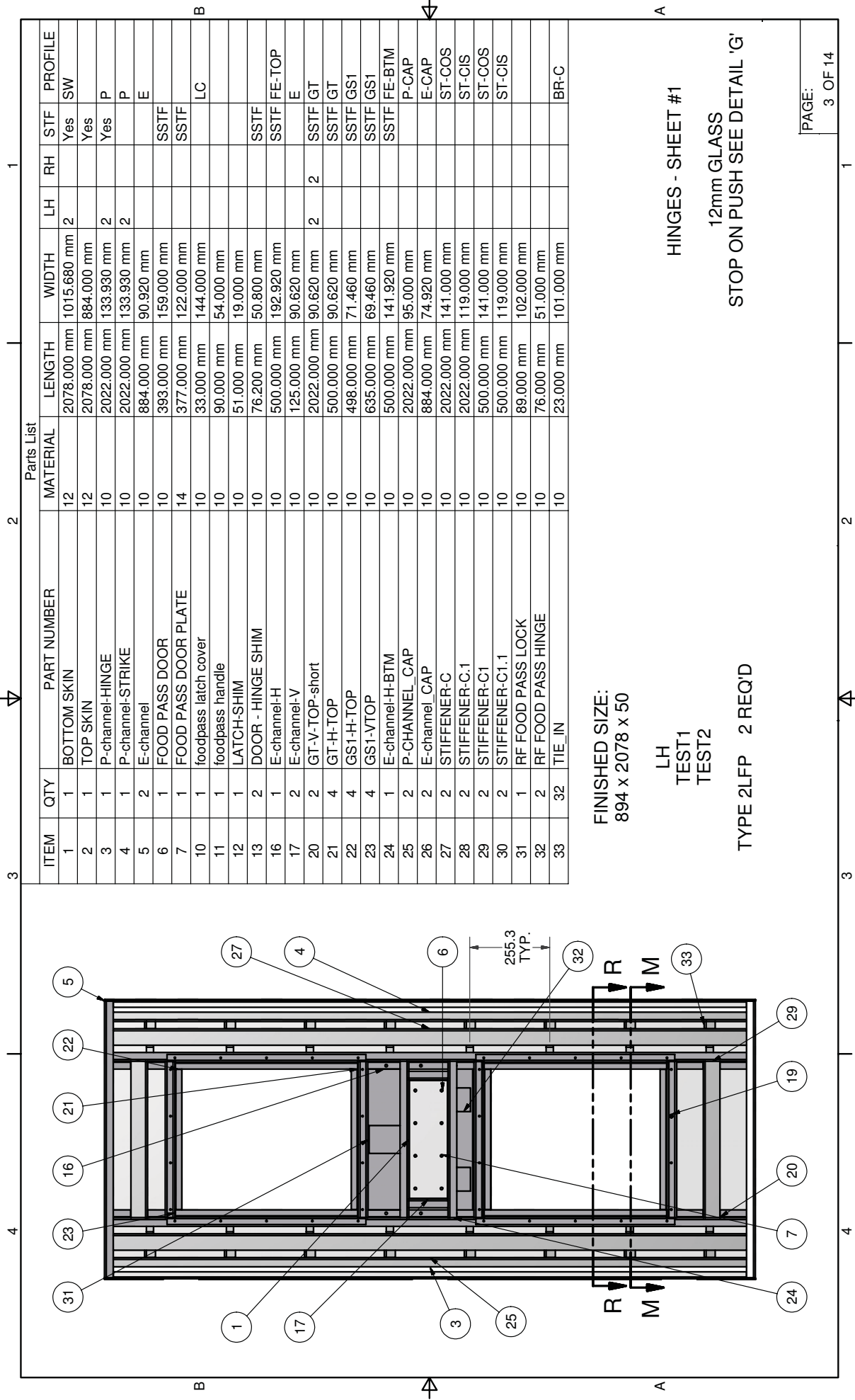
**1. SPECIFICATION**

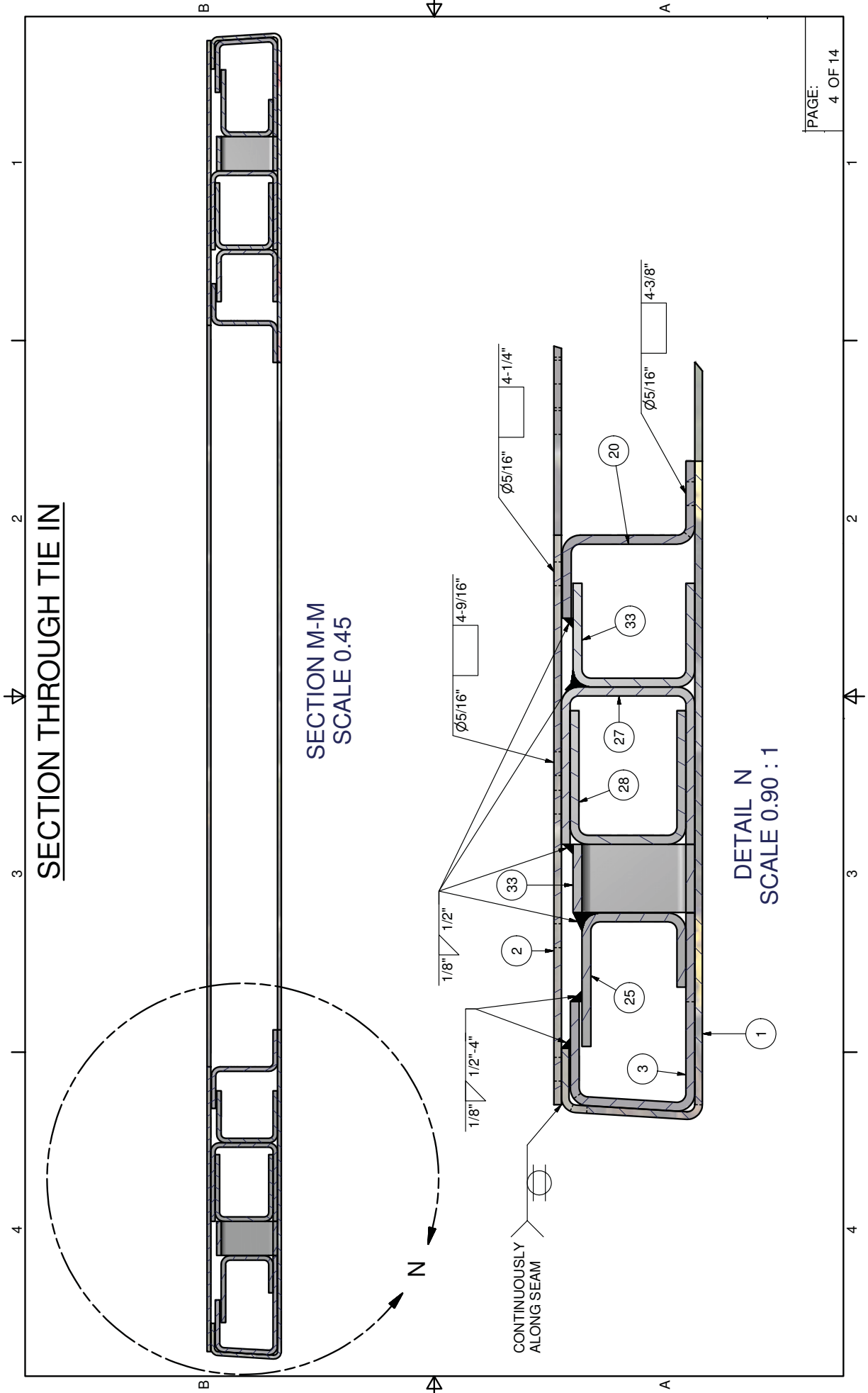
- .1 In Specification Section 01.14.10, remove entire clause 1.4.3 "*To assure...*", 1.4.4 "*Off hours...*" and 1.4.5 "*the following...with operations.*"
- .2 The service space between the cells in B4 is **not** a *confined space* and is identified as a *restricted area*. This being said, when a space is considered as a Restricted Area the following procedures apply:
  - Advise another employee of the location of this restricted area.
  - Ensure radio communication is possible with this other employee. Maintain periodic communication during work.
  - Advise this same employee of the type of work to be conducted.
  - Advise this same employee of the length of time expected to be in the space.
  - Give any other directions to this employee, under the circumstances, to ensure that the notified employee is able to provide assistance if needed.
  - Advise this employee when the work in the restricted area is complete.
  - Under special circumstances, restricted areas may be considered confined spaces, e.g. during hot work. When this is the case, a hazard assessment is to be carried out and appropriate permits need to be filled out.
  - Continuous air monitoring is recommended.

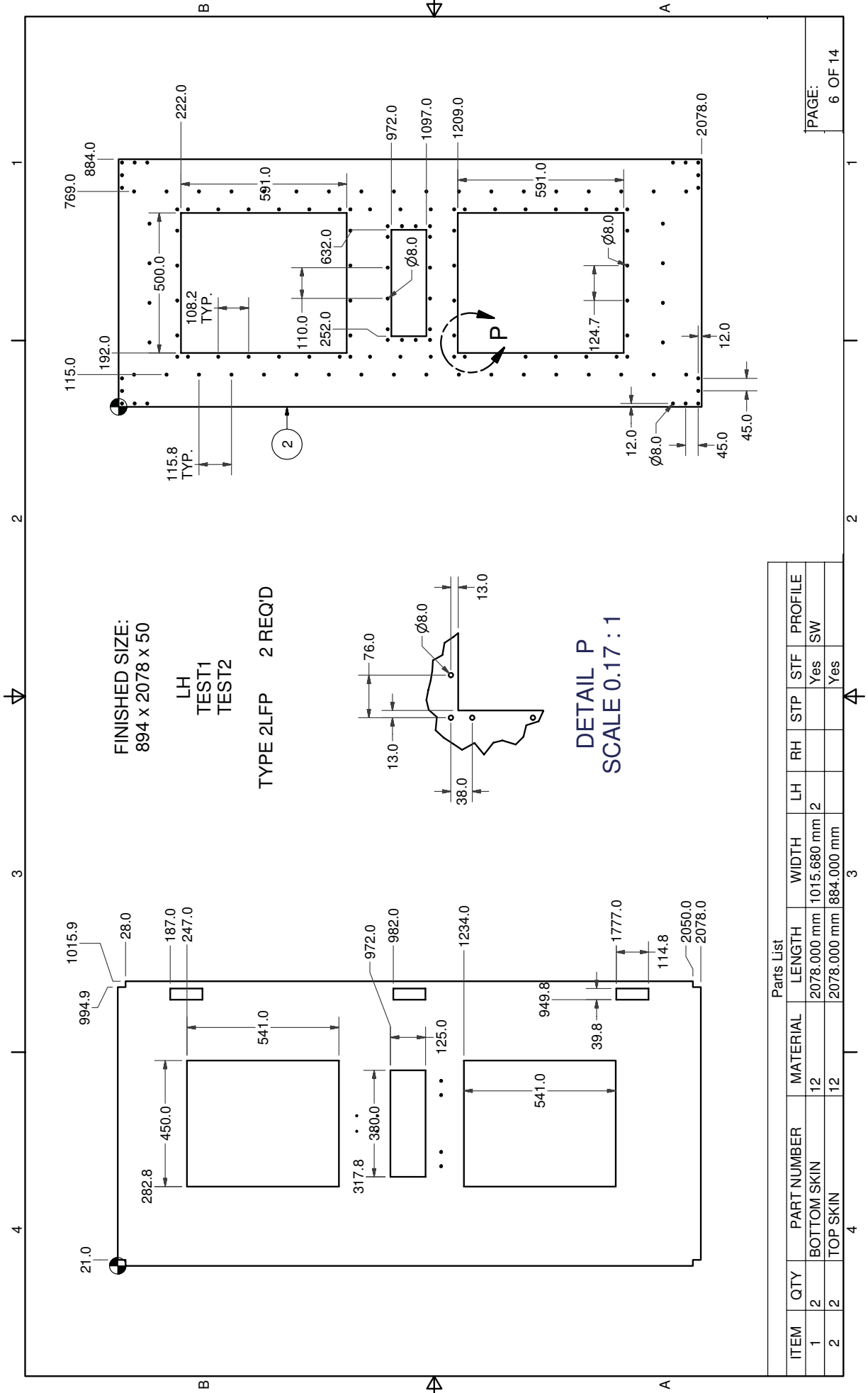
