1. QUESTION AND ANSWER

Q1: Can the sanitary facility be located inside prison walls (refer to 01 50 00 1.8.1)?

A1: Yes, a sanitary facility will be allowed within the prison walls. The sanitary facility would require to be fenced in. Jersey barriers c/w fence on top are acceptable as well. Location of sanitary facility will be coordinated during construction with institution.
