1. QUESTIONS AND ANSWERS

Q1: New cell storage unit – do these new units received a metal backer panel the detail shows a thicker black line between the wall and the shelving unit but does not indicate if there is a metal backer panel or not?

A1: Drawing A-3 detail 1/2/3 Typical Desk / Shelving Unit Plan call for an 11 Ga. Back panel secured to wall.

Q2: Section 07 92 10 Joint sealants – what specifically needs to be caulked in the cell?

A2: Caulking will be required between Desk / Shelving Unit and adjacent wall, also at head of front wall to slab above as indicated.
