MANDATORY TECHNICAL CRITERIA

1. The bid must meet the Mandatory Technical Criteria specified below. The Offeror must provide the necessary documentation to support compliance with this requirement.
2. Offerors must submit a minimum of ten (10) photos in support of their bid and the photos will be evaluated. If more than ten are provided, the Offeror must indicate which 10 they wish evaluated and graded. Photos will be awarded points for three factors, Technical, Composition and Photojournalistic, and further subdivided into elements. Failure to meet these elements will lead to the bid being rejected.
3. Bids which fail to meet the mandatory technical criteria will be declared non-responsive. Each mandatory criterion should be addressed separately.
