## Questions and Answers

---

1. Do both items ,the vest and cap, have to be made in Canada, or will you allow offshore content?

**Answer:** Yes, offshore content is allowed.

2. In this tender, the required colour is specified in sections 3.1.4.1.1, 3.1.4.2.1 and 3.2.4.1.1 as follows:  
"Dark Navy Blue in accordance with Pantone Color – Textile #2767"

In our experience, textile pantone colours are normally formatted as 6 digits followed by the letters "TCX" (17-4015 TCX for example).

The above code appears to be the Pantone paper reference, such as 2767 C.

Please advise which system we are to be using to dye our fabric accordingly. Would it be acceptable to use Pantone 2767 C as a reference?

**Answer:** The Statement of Work (SOW) has been amended to include the correct colour references. Please see amendment below.

3. DoubleTex has their own lab. Is their test report acceptable?

**Answer:** As outlined in Section 2.1 Pre-Award Sample and Supporting Documentation of Attachment 1: Mandatory Criteria, Testing must be performed by an independent accredited laboratory establishment and must be in accordance with the test methods detailed in the Statement of Work.

4. Do you accept goods made overseas?

**Answer:** Yes, goods made overseas are accepted.
