Addendum No. 1.

1. QUESTION AND ANSWER

Q1. The documents specify “within New Brunswick”. Do you have a breakdown of these areas in New Brunswick and any idea of what percentage of the contract would be applicable to those areas.

For example; the pricing to move offices from one floor to another in Saint John would be one price and the same job in Bathurst would have to reflect the windshield time for an out of town job. How do I include that charge in my bid?

A1. The contract is all of NB we are allowing a 2 hour travel time to sites each way for employees and vehicles. That being said, historically approximately 70% of the work is in Moncton with the rest so far having been in Fredericton and Miramichi. We preview in the future some potential work in the Mirimachi and Fredericton as well so all should stay the same. We have had to go this route as limiting ourselves to one city precluded places like Miramichi in fact we were only able to move around Moncton area and could not even service the other major centres. So the vehicle rates should be high enough to cover the cost of gas and wear and tear to and from the site by the hour.
