This amendment is being raised to make revision to PD 3.2.4 (7) and provide responses to Requests for Clarification.

Revision to PD 3.2.4 Ranney Falls Dam 10 and Locks 11 & 12 (7)

Based on the Parks Canada Directive for Dam Safety Program of Parks Canada Dams and Water-Retaining Structures, the dam has been assigned a preliminary Dam Classification of **High A**.

Requests for Clarification

Q14. The Price Proposal Form breaks the cost of services into 4 fixed fee amounts, one for each site. The dam break and inundation analysis due to the cascading nature of the sites is very interrelated.

Is it possible to quote the Required Services (RS) as follows:

RS1 Dam Break and Inundation Mapping

RS2 Dam Safety Review

.1 Frankford Dam 6 & Lock 6

.2 Meyers Dam 8 & Lock 9

.3 Hagues reach Dam 9 & Lock 10

.4 Raney Falls Dam 10 and Locks 11 & 12

RS3 Geotechnical Investigation Program

A14. The consultants are to provide costs as per Appendix C of the RFP. The consultant is to decide how they include the pricing for the dam break and inundation analysis.

Q15. The RFP (Page 24 of - de 96) states the High B classification for the Ranney Falls Dam 10 while the Dam Data Sheet shows High A. Which one is the preliminary classification for the Ranney Falls Dam 10?

A15 Page 24 should have said High A. See Revision to PD3.2.4 (7) above.

Q16. The item PA 3.1.2 of RFP is requiring that the site photos are to be taken using a GPS camera in order to upload easily in Parks Canada's ArcGIS database. Does the Parks Canada ask consultant to use a specific camera, for site visit, in order to be compatible with their system?

- A16.** Any camera that has the ability to provide GPS coordinates when taking photos will suffice.
- Q17.** The RFP (section PD 2.1) lists the dams and locks under this study. Meyers Dam 8 & Lock 9 is one of those dam sites. But the Dam Data Sheet states name of the dam as "Meyers Dam & Lock 9". As the Lock 8 is located just downstream of the Lock 9. Is Lock 8 in the scope of work?
- A17.** Lock 8 is not part of the scope
- Q18.** Could you please provide the bidders with additional information/drawings regarding all of the retaining structures (concrete and earth) for the purposes of determining what retaining sections should be analyzed for stability (i.e., to determine what structures are related to dam safety).
OR
Could you please identify which retaining structures should or should not be included as part of the dam safety review. For example, for the Talbot Bundle DSR, the stability analyses of the concrete structures were limited to the dams and lock chambers only. The concrete retaining structures upstream and downstream of the lock chambers were excluded.
- A18.** **In PD3.2, the structures to be addressed are identified in the photos and in the text; the photos are also provided on the DVDs. All available cross sections are included in the DVDs as well.**
- Q19.** Will the successful proponent be provided with sufficient information to do stability analyses for all retaining structures that are to be included in the dam safety review?
- A19.** It is understood that additional geotechnical information will be required and this would be covered under RS 2 Geotechnical Investigation Program. Also, PWGSC will be providing additional information as per RS1.3.1.a).iii)
- Q20.** In SRE 2.2 Specific Requirements for Proposal Format, the page limit is given as Forty (40) pages and a list of documents not considered to be part of the page limitation is given below. We noted that CVs / Resumes are not part of this list and therefore the list appears to imply that any CVs / Resumes included in our proposal package would count as part of the 40 page limit.
- A20.** **CVs/Resumes are provided, they are count as part of the 45 page limit. See Amendment No.002.**

All other terms and conditions remain the same.
