QUESTION 1

Stream 6: ERP Programmer Analyst Level 2 - R.4 awards points for experience over and above the 5 years required in M.1. 5 additional years (i.e. total of 10 years of experience with SAP version 4.7 or higher) are required to score the full 15 points. Given that SAP 4.7 was released March – December 2003, finding a resource with 10 years of experience is near impossible. Would the client consider amending the requirement to award 5 points for each additional year of experience on top of the 5 years required in M.1 so that a total of 8 years of experience is required to score full points for R.4?
