Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

 - (e) clearly identifies those areas in the specifications and descriptive literature that support the substitute product's compliance with any mandatory performance criteria.
2. Products offered as equivalent in form, fit, function and quality will not be considered if:
 - (a) the bid fails to provide all the information requested to allow the Contracting Authority to fully evaluate the equivalency of each substitute product; or
 - (b) the substitute product fails to meet or exceed the mandatory performance criteria specified in the bid solicitation for that item.
3. In conducting its evaluation of the bids, Canada may, but will have no obligation to, request bidders offering a substitute product to demonstrate, at the sole cost of bidders, that the substitute product is equivalent to the item specified in the bid solicitation.

ANNEX "A"

STATEMENT OF REQUIREMENT

Quantity: one (1)

For 200 KV High Voltage AC Test System

A new precision and adjustable 200 kV high voltage AC test system is required to enhance Electrical Power Measurement test capabilities, upgrading from the existing 100 kV supply. The high voltage AC test system must consist of a high voltage step up transformer, a regulator, and a control unit. The system is for indoor use only.

1. General specifications for high voltage AC test system:

Output Voltage:	0 to 200 kV AC adjustable
Output Current:	300 mA maximum
Capacity Rating:	60 kVA (continuous), 80 kVA peak (intermittent)
Frequency:	50 and 60 Hz
Waveform Distortion:	Maximum output waveform distortion must be less than 5% total harmonic distortion (THD)
Partial Discharges:	Must be less than 2 picoCoulombs at all voltages
Input:	Must be 600 VAC (+/- 5%) single phase (will be connected to two phases of 600 phase-phase 3 phase supply)

High Voltage Equipment Category: For indoor laboratory use ($20 \pm 5^{\circ}\text{C}$, 5-70% RH)

Regulatory requirements:

Safety approval - CSA (Canadian Standards Association) approval required
 Accuracy traceability - Traceability of system calibration to National Research Council Canada (NRC) or National Institute of Standards and Technology (NIST)

2. High Voltage step up Transformer:

- Input: 0 - 600 VAC, 50/60 Hz
- Output: 0 - 200 kV AC, 50/60 Hz
- Step up taps: at least two tap positions, to ensure lower voltage waveform accuracy.
- Calibrated High Voltage: voltage and current secondary outputs to Control Unit
- Corona and PD free (2 pC) HV Bushing

- Maximum weight of transformer (with oil): 1700 kg
- Maximum Height at top of HV bushing: 2.5 meters
- Transformer tank must be moveable via casters and forklift or crane.
- Connecting cable(s) between Transformer and Regulator must be at least 10 meters, and must have standard (commercially available) connectors at least unit so the units can be separated.

3. Regulator:

- Input: must be 600 (+/- 5%) VAC, 50/60 Hz, single phase (via terminal block for input supply cable, input cable will be supplied by NRC)
- Output: 0 - 600 VAC, 50/60 Hz, single phase cable to High Voltage Transformer
- The regulator must have an Input Circuit Breaker for incoming line power
- Regulator must be moveable via casters and/or forklift

4. Control Unit:

Mechanical/Safety Requirements

- Separate Operator Control unit with display and controls, must be standard 19 inch (482.6 mm) IEC rack mount or rack mountable chassis
- Must have a Safety Interlock input - terminal block for connection to external interlock circuit
- Must have Key lock to prevent unauthorized access (may be integrated with other control)
- Minimum set of discrete operator controls: Power On/Off, Emergency power off, High Voltage On, High Voltage Off, High Voltage raise, High Voltage lower
- System must be equipped with a fast acting primary current overload trip function
- External Computer Interface: Must have Ethernet Data acquisition and remote control interface

Operational Requirements

- Must provide for manual and automated operating modes for control of voltage level and monitoring of current
- Minimum set of monitored and displayed parameters in manual operation: Supply Voltage, Supply Current, Supply Frequency, High Voltage Output Voltage, High Voltage Output Current
- Operator Interface must provide control of voltage increase/decrease rate, timers, High Voltage Transformer Tap control, and automatic test modes including:
- Must provide closed loop control of the rate of Voltage rise, adjustable in 10 V/s increments
- System must include total duration and dwell timers

-
- System must be able to switch from manual to automatic mode and back while operating, without having to turn off high voltage.
 - System must maintain set point at better than 1% of total tap voltage.
 - System must be equipped with a primary (high voltage) current overload adjustable in 1mA increments.

5. Support

Warranty - minimum period 12 months.

6. Training/Documentation

Training (in English): for up to three (3) people for a period of up to two (2) days.

Location: The National Research Council Canada/Electrical Power Measurements high voltage lab in building M-50 in Ottawa.

The contractor shall provide training for the operational technical staff. The training shall be conducted on-site at the location indicated above.

7. Documentation

Training material shall be provided in English. The contractor shall provide one copy of the training material to each participant at the beginning of the training session.

NRC shall stipulate the number of staff who will be trained.
