This Solicitation Amendment #002 is raised to provide potential Suppliers with updated information pertaining to site visits and one-on-one consultations.

As a follow-up to the Industry Day presentations for the Atomic Energy of Canada Limited's (AECL's) Government-owned, Contractor-operated (GoCo) Procurement, Canada has revised the dates for site visits and one-on-one consultations. Potential suppliers who are interested in the AECL GoCo Procurement may be invited to participate in one-on-one meetings with Canada to provide feedback on the draft Request for Response Evaluation and process. These meetings are scheduled to be held in August, 2013 in the National Capital Region. Further information will follow. Potential suppliers will be limited to no more than 8 participants from their organization(s).

Site visits are also anticipated for August, 2013. For those suppliers who attended site visits during the Request for Expression of Interest process, the format and site access granted are expected to be similar. These visits are not mandatory for participating in any future solicitation. More details will be provided in a future amendment and the upcoming Request for Information.
