SPECIFICATIONS

1. In the Specifications, Section 03 35 05 – CONCRETE FLOOR HARDENING, delete Clause 2.1.1 – FLOOR HARDENER and replace with a new Clause 2.1.1 to read:

.1 Integral Concrete Hardener which is added integrally into the concrete mix during the batching process.

.1 Ferrous Granules

2. In the Specifications, Section 03 35 05 – CONCRETE FLOOR HARDENING, delete Clause 3.2.1 – HARDENING and replace with a new Clause 3.2.1 to read:

.1 Apply floor hardener aggregate at rate of 40 kg/cu.m. or in accordance with manufacturer's written instructions. Adjust the proportions of other concrete materials to account for the added hardener and provide the specified strength of concrete.
