It is requested that the CPIC Clearance Requests be received by this office no later than 4:00pm on July 23rd 2013. **Site Clearance Request Forms received after 4:00pm on July 23rd 2013 may not be accepted.** A site clearance obtained for work performed under similar requirements is not acceptable. Bidders are requested to clearly identify the name of the participant, the name of the company they represent, telephone number, facsimile number and e-mail address.

Bidders should submit in writing to the Contracting Authority, a list of issues that they wish to table and the language they would like to address questions and answers, no later than five (5) calendar days prior to the scheduled site visit.

Bidders are advised that any clarifications or changes resulting from the site visit shall be included as an amendment to the bid solicitation document through Buy and Sell.

As proof of attendance, the Bidder must sign the attendance form provided by the CSC representative at the site visit.
