Questions and Answers No. 108

Q108: Please confirm Canada's answer to Question 100 shall mean that, when a bidder proposes an individual to work on the ISSP program, the proposed individual will not be required to meet the individual personnel security screening level, as defined in the SRCL set out in Volume 2 Annex AC and Volume 3 Annex AC, until contract award.

A108: It is not Mandatory at bid closing for the bidders submission to include the Individual Security Level Certification BUT during the evaluation of the proposals, the Contract Authority will request proof of the proposed Individual Security Level Certification per Volume 2 Article 3 and Volume 3 Article 3.
