*The intent of this amendment is to provide a clarifying response to Industry poised questions and amend the RFP.*

**Questions and Answers No. 109 to 110**

**Q109:** Can you please advise what frequency will be given at the UAPE Trials?

**A109:** All bidders will receive a primary and an alternate frequency in their Performance Evaluation invite letters.

**Q110:** Volume 1, Part 6, Para 6.2 of the ISSP solicitation W8476-112965/B refers to the requirement for the Bidder to be registered, exempt, or excluded under the Controlled Goods Program (CGP) before examining, processing or transferring controlled goods. If the Bidder is a Joint Venture (JV), and one of the parties to the JV is a foreign company, is it sufficient that at least one other party to the JV be registered under the CGP, in a similar manner to how the COMSEC requirements are satisfied?

**A110:** Any member of the JV requiring access to controlled goods must be registered, exempt or excluded under the CGP before access can be authorised.
