Amendment 001 - Milk and Dairy Products

Questions from bidders with response back from Public Works and Government Services Canada.

Q1. On page 17 – Statement of Requirement, paragraph 11 – “Milk supplied to have a minimum 18 days before expiry date”.

Is this required for all 3 Pricing Basis?

A1. Yes, this is required for all 3 Pricing Basis.

Q2. Is there a possibility to have this changed to: Milk supplied to have a minimum of 7-10 days before expiry date on date of delivery?

A2. Annex A - Requirement will not be changed.

Q3. With multiple delivery days weekly, product would be consumed well before the 7 days.

Product will have an average of 12 days shelf life, and we would guarantee a minimum of 7 days.

Is there any opportunity to have this changed?

A3. CSC cannot guarantee that the product will be consumed before the 7 days due to operational issues that may occur without notice, therefore there is no possibility to change this requirement.

Q4. Pricing Basis “A”– item #3– milk 1% 250 ml pouch or carton – we can only sell these as a full case – packed either 24 or 36 units per case. Is this acceptable for our customer?

A4. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis “A”, “B” and “C”.

Q5. Pricing Basis “A” – item #5 – half and half – we can only sell these as a full case – packed in 12x 1 lt per case. Is this acceptable for our customer? CSC requires the pricing based on each not on case cost.

A5. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis “A”, “B” and “C”.

Q6. Pricing Basis "A" – item #6a) – sour cream – 500 gm – we have this available in case size of 6 x 500 ml or 12 x 500 ml – is this acceptable for the customer? CSC requires the pricing based on each not on case cost.

A6. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis "A", "B" and "C".

Q7. Pricing Basis "A" – item #9 – Yogurt – 750 gm – we have this available in case size of 6 x 750 gm – is this acceptable? CSC requires the pricing based on each not on case cost.

A7. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis "A", "B" and "C".

Q8. Pricing Basis "A" – Kingston Area – item #10 – Ice cream – 1 x 2 lt - We have this available in case size of 4 x 2 lt – is this acceptable for our customer? CSC requires the pricing based on each not on case cost.

A8. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis "A", "B" and "C".

Q9. Pricing Basis "B" – Item #2 - milk 1% 250 ml carton – we can only sell these as a full case – packed either 24 or 36 cartons per case. Is this acceptable for our customer? CSC requires the pricing based on each not on case cost.

A9. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis "A", "B" and "C".

Q10. Pricing Basis "B" – item #3 – Chocolate milk – 1 lt - we can only sell these as a full case – packed in 12x 1 lt per case. Is this acceptable for our customer? CSC requires the pricing based on each not on case cost.

A10. CSC requires pricing to be provided as stated in Annex B - CSC Milk and Dairy Products, Pricing Basis "A", "B" and "C".
