<u>Industry Engagement Day Notice for the Data Centre Consolidation Program</u>

Shared Services Canada (SSC) is accountable to the Minister of Public Works and Government Services to modernize how the federal government manages its information technology (IT) infrastructure in order to better support the delivery of programs and services to Canadians. *The Shared Services Canada Act* and the accompanying Orders in Council mandate SSC to provide email, data centre and telecommunications services to partner federal departments and agencies, as shown in Annex A. SSC also provides optional services to government departments and agencies on a cost-recovery basis.

SSC will transform its services through consolidation, standardization, and renewal to generate savings, improve service, and increase security. SSC is currently working towards the following:

- a) Moving towards one secure, reliable and cost-effective email system;
- b) Reducing the number of data centres to fewer than 20 modern, secure and reliable centres;
- c) Designing and building an integrated telecommunications network to support Government of Canada (GC) operations from coast to coast and internationally; and
- d) Protecting the integrity, accessibility and reliability of the GC's IT infrastructure, and the personal information of Canadians.

On July 17, 2013, Shared Services Canada will host an information session in the National Capital Region, with video conferencing rooms available at the selected sites listed in Annex E, to present the current state of the data centre services that serve the partner Government of Canada departments and agencies, and its "Data Centre Consolidation (DCC) Program," which is Shared Services Canada's plan for improving the delivery of these services. This "Industry Engagement Day" session is open to all interested suppliers and associations from the IT Industry. Following the DCC Program Industry Engagement Day, One-on-One meetings will be held from July 22 to 26 with Industry representatives who wish to provide further input. All media inquiries related to the DCC Program should be directed to the Media Relations Office at (613) 947-6276. The purpose of the session is for Shared Services Canada to present information and elicit feedback from Industry on the following topics:

- The scope of the Data Centre Consolidation Program;
- Data centre services and the best and most innovative options available in the market today that will support the Government of Canada's requirements;
- The role of Industry as a contributor to the transformation of the GC's IT infrastructure;
- The proposed "Collaborative Procurement Solutions" approach; and
- The Cyber Security Supply Chain Integrity Threats.

Specifically, the GC is seeking feedback on the scope, requirements, and delivery options related to the provision of platforms and data centre services for the GC. The GC is particularly interested in discussing and understanding how vendors will:

- 1. incorporate emerging trends/technologies into their proposed solutions, while meeting GC's security requirements;
- 2. leverage Government Furnished Equipment / assets, lessons learned, and previous experiences in delivering similar data centre service solutions;
- 3. address application migration and integration issues related to the introduction of new infrastructure, including the use of automation tools;
- incorporate usage-based or size-based licensing options, just-in-time capacity methodologies, innovative financing or other additional benefits related to the service provided;
- 5. utilize maximum pre-delivery configuration and integration; and,
- 6. address perceived barriers to success and risks that require mitigation strategies.

The details herein are intended to help prepare Industry for the upcoming Industry Engagement Day and the One-on-One meetings for the Data Centre Consolidation Program.

National Security Exception: The procurement related to this initiative is subject to National Security Exception and is, therefore, excluded from all of the obligations of the trade agreements.

BACKGROUND INFORMATION

SSC will streamline and reduce duplication in the government's IT services. The IT infrastructure consists of the underlying IT equipment, software, networks and supporting organizations required to deliver government programs and services. Standardizing and consolidating IT services will reduce costs, improve services, leverage capacity in the public and private sectors through pooled resources and greater buying power, and strengthen the security of GC data to ensure Canadians are protected. Data centres provide all of the computing, storage and hosting services for application services across the GC and are key enablers of service delivery to Canadian citizens and businesses, both at home and abroad.

CURRENT STATE OF DATA CENTRE SERVICES

Shared Services Canada, as of January 8, 2013, operates and maintains 485 data centres and an additional 2,718 points-of-presence (server locations) for its partner organizations. Housed within these data centres the GC has around 70 PB of online storage, 130 PB of off-line storage and 23,424 servers with an average utilization rate per server of 12%. These assets are maintained by independent teams to manage server and storage infrastructure for partner organizations.

BUSINESS OUTCOMES OF THE DATA CENTRE CONSOLIDATION PROGRAM


The current state of GC data centres does not address the government's objectives to eliminate duplication in IT services, reduce the government's IT footprint, and reduce costs. By implementing a comprehensive modernization strategy across all of the GC, the DCC Program will deliver efficient, scalable and standardized data centre services that will reduce operating costs for government data centre services as a whole.

The DCC Program will achieve the following business outcomes:

- <u>Savings</u> Transformation, consolidation and standardization of data centre services will realize
 material and ongoing cost savings through economies of scale and avoidance of future costs.
 Savings will also be generated by a reduction in energy consumption and carbon footprint.
- <u>Service</u> Transformation, consolidation and standardization of data centre services will better
 enable the delivery of government services to Canadians by improving availability, scalability
 and agility of IT infrastructure services. Better services mean responsiveness to business
 demands and improved client satisfaction. Outcomes will be measured through increases in
 capacity and speed, improved response times, and reductions in service calls and service
 outages.
- <u>Security</u> Transformation, consolidation and standardization of data centre services will provide
 a secure technology infrastructure and environment to meet program needs, increase the
 confidentiality and integrity of information, enable enhanced cyber security, and strengthen
 Canada's national security. Outcomes will be measured by a reduction in vulnerabilities,
 security breaches, and improved audit findings.


CONTRACTING AND PROCUREMENT

SSC will be utilizing a collaborative procurement approach throughout transformation, as was done with the Email Transformation Initiative, in order to generate new ideas based on Industry input. This iterative approach to requirements definition will involve Industry vendors and will reduce the probability of ill-defined requirements leading to change requests. The defined requirements will balance what Industry can provide cost effectively and rapidly with a solution that meets the GC's needs. Contract terms and conditions will also be defined in collaboration with Industry. The Review and Refine Requirements Phase of the approach will be conducted with Successful Respondents in order to validate requirements and develop solution approaches and strategies.



INDUSTRY ENGAGEMENT PHASE

The "Industry Engagement Phase" is the first phase of the DCC Program's procurement process, and it has 3 stages:



- 1. <u>Industry Engagement Day Session</u>: This will be the first face-to-face engagement with Industry specific to the DCC Program, building on the work being done through SSC's IT Infrastructure Roundtable. The purpose of this session is for Shared Services Canada to:
 - Present the scope of the Data Centre Consolidation Program, which includes:
 - Shared Services Canada's mandate; and
 - o The data centre services transformation plan and service delivery options.
 - Data centre services and the best and most innovative options available in the market today that will support the Government of Canada's requirements;
 - The roll of Industry as a contributor to the transformation of the GC's IT infrastructure;
 - Explain the proposed "Collaborative Procurement Solutions" approach;
 - Address the Cyber Security Supply Chain Integrity Threat; and
 - Elicit feedback from Industry, which includes:
 - Assessing the level of interest among companies and industry associations in providing a solution for the new data centre services;
 - o Determining the general capacity of companies to meet key requirements; and
 - o Identifying any concerns with, or ideas for, the scope, requirements and procurement approach of the DCC Program.

Presentations made by Shared Services Canada, the list of attendees and general responses to questions will be published via the Government Electronic Tending Service after the Industry Engagement Day session.

- 2. <u>Industry Engagement One-on-One Meetings</u>: Suppliers and industry associations will have the opportunity to participate in 45-minute one-on-one meetings with GC representatives following the Industry Engagement Day. These meetings are intended for data centre services solution providers or manufacturers to provide additional feedback on the procurement process, scope and requirements presented on Industry Engagement Day. There will be no fixed agenda, however, Shared Services Canada would like to discuss:
 - Platform and Infrastructure solutions and implementation approaches, in alignment with the DCC End State platform architecture and standards;
 - Feedback on the scope, requirements, procurement process and service delivery options; and
 - Best practices and/or case studies that the supplier/association wishes to bring to the meeting regarding the transformation of data centre services.
- 3. <u>Request For Information Process:</u> All DCC Program Request for Information (RFI) solicitations will be posted on the Government Electronic Tendering Service in due course. RFIs will be an

avenue whereby Industry can submit written feedback and responses. This will provide additional opportunities for suppliers/associations that were unable to participate in the previous events of the Industry Engagement Phase, to submit written vendor feedback on best practices, requirements and challenges. Feedback from the Industry Engagement Day will be used to inform the RFI process going forward. Once the RFI process commences, each RFI may consist of the following milestones:

- a) RFI Posting and Responses from Industry to the RFI
- b) RFI Industry Workshop Sessions
- c) RFI One-on-One Meetings

Shared Services Canada intends to leverage the feedback from the Industry Engagement Phase to determine a data centre services' transformation strategy and solidify the procurement approach. Moving forward, Shared Services Canada will require vendors to hold a security clearance level of Secret or higher to proceed with subsequent phases of the procurement.
