The purpose of this amendment is to respond to the following question posed by a potential Offeror;

Q1: The Offeror is asking if their request for security clearance from Solicitation A remains valid for Solicitation B or will they need to re-apply for clearances specifically related to Solicitation B?

A1: The security provisions required in Solicitation B have not changed from Solicitation A. To confirm the security requirements:

1. Offerors representing Canadian firms must submit the information noted on page 5 of the solicitation document to the Standing Offer Authority as soon as possible to initiate the security clearance process. Those Offerors (Canadian firms only) who have previously submitted the information are not required to resubmit.
2. Offerors representing Foreign firms (non-Canadian firms), must first obtain the clearances at the appropriate level (Confidential) in their country and submit their approved clearances to the Standing Offer Authority once they are cleared in their country. Canada does not initiate this process, it is the responsibility of the Offeror to initiate their own clearances in their country. However, Canada will verify and accept foreign Offeror's clearances at the same or higher levels.

All other terms and conditions remain the same.
