(3) REQUESTS FOR CLARIFICATION

Q1. We have a question regarding the maximum number of pages to be submitted for the Rated Requirements under SRE3.2.

Given the different methodologies to be described, and distinct schedules and work breakdown structures to be provided for the large number of dam sites, we were wondering if an additional ten (10) pages could be granted for this proposal document.

A1. Please refer to Amendment No. 001, Revision (2)(i).

Q2. Considering that the number of pages for the technical proposal is limited to 40, could we submit in the proposal only one schedule and WBS for one site (as all sites are relatively similar; any difference would be noted in the text), and include the other ones as appendices? This would help us to optimise the use of available pages.

NOTE: Gantt chart and PWBS are on 11 x 17 paper format and each would count for 2 pages in the proposal, thus, they would use 12 pages of the proposal.

A2. Please refer to Amendment No. 001, Revision (2)(iii).

Q3. Considering all the information requested, would you allow at least 10 additional pages for the proposal?

A3. Please refer to Amendment No. 001, Revision (2)(i).

Q4. If we include the complete curricula vitae, would they be counted in the total count of pages of the proposal, or can we submit them as appendices?

- A4. Curricula vitae/Resumes submitted in response to Rated Requirements will be evaluated, and will therefore be included in the total page count.
- Q5. If we use tabs as table of content dividers, will they be counted in the total number of pages?

- Q6. As per the Lower Rice DSR RFP could the page limit please to extended from 40 pages to 45 pages.
- A6. Please refer to Amendment 001, Revision (2)(i).
- Q7. As per the Lower Rice DSR RFP could instead of doing one schedule for each of the 7 sites could one detailed schedule be provided for just one site and another higher level schedule be provided including the milestones and deliverables for the remaining 6 sites.
- A7. Please refer to Amendment 001, Revision (2)(iii).
- Q8. As per the Lower Rice DSR RFP could instead of providing a work breakdown for all 7 sites could a work breakdown be provided for only one of the sites.
- A8. Please refer to Amendment 001, Revision (2)(iii).
- Q9. Could you please identify which sites have electrical components to them and for the sites that do have electrical components could you please specify the terms of reference.
- A9. Buckhorn is the only dam with the radial-arm "fishbelly" taintor gate as indicated in the Project Description section of the RFP.
- Q10. We are unable to locate the following document that is referred to throughout the Project Description Section.
- Can you please let me know if this should be included within the document package...
- Consultant is to review the report on Mitigation Measures for High Risk Dams in Ontario (Northern Sector) produced by Genivar in 2011 for additional information on the condition of the assets, and more specifically for any particular issues raised during the 2011 inspection. The report is included in the appendices in a sub-folder of the 'Other Information' folder."
- A10. Please refer to Revision (1)(i) above. References to that document have been removed.
