SECTION “I” – SUBMISSION REQUIREMENTS AND EVALUATION

SR1 INTRODUCTION

In 2012 the Department of Foreign Affairs, Trade and Development (DFATD) established a permanent source list for procurements of vehicles for Canadian Embassies worldwide. This RFP serves to advertise the existence of the list and represents the first of a two-phase evaluation process. Phase 1 seeks to invite suppliers to the permanent supplier list. Phase 2 includes the solicitation for individual requirements, should they arise.

1.1 Description of the Requirement

Canadian Embassies must at all times have at their disposal the use of vehicle(s) meeting specific criteria to support operational requirements. The vehicles must periodically be replaced with suitable substitutes.

- 1.2 PHASE 1 RFP:** The purpose of this solicitation is ONLY to provide public notice of the source list and expand it by identifying organizations capable and interested in supplying vehicle(s) which may be required by DFATD. This is a permanent source list with no expiry date. The source list is based on an evaluation of the company’s capability to supply vehicles in the specific required size class(es), and providing an authorized warranty approved full-service and parts location within 25 km of the location of the Embassy, capable of providing after-sales service for the life of the vehicle while in Canada’s possession. When a requirement for (a) vehicle(s) arises, the companies on the source list will be included in Phase 2 of the procurement process, and be issued a Request for Quotation (RFQ) to fulfill the specific requirement. Your company will be invited to participate in the Phase 2 RFQ for the vehicle classes and location(s) you indicate in Phase 1.

Companies already registered on the suppliers’ list are not required to re-apply, but may at any time update their information to add or delete locations, vehicle classes, or change contact information.

Canada reserves the right to add, delete, or modify, the list of embassy locations.

This solicitation concerns Phase 1 only.

- 1.3 PHASE 2 RFP:** The future Phase 2 RFQ(s) will be comprised of two (2) parts: (a) a technical component (specifications for required vehicle), and (b) a fixed price for the required vehicle. In addition, Phase 2 proposals must meet the mandatory requirements set out in the RFQ for Phase 2. Proposals not meeting the mandatory requirements stipulated in the Phase 2 RFQ, will not be given further consideration. Should Canada elect to proceed with a Contract, the Proponent

meeting all mandatory technical criteria with the lowest cost, will be recommended for Contract award. The Phase 2 RFQ(s) will be issued only as-and-when vehicle(s) is/are required. There is no limit to how many Phase 2 RFQ(s) may be issued, as this is based solely on operational requirements.

- 1.4 The evaluation will be based solely on the content of the supplier responses and any correctly submitted amendments. No assumptions should be made that Canada has any previous knowledge of the Proponents' qualifications other than those supplied pursuant to this RFP.
- 1.5 Nothing in this RFP shall be construed as an offer or legally binding commitment on the part of Canada to enter into a Contract with any party.

SR2 PREPARATION OF THE PROPOSAL

2.1 Mandatory Requirements

2.1.1 Annex "A"

Proponents must complete in every detail and submit with their proposal, Parts 1 and 2 of Annex "A" – Source List Questionnaire.

SR3 Evaluation of Proposals / Basis of Selection

- 3.1 All proposals submitted must be signed and provide all of the information requested in the RFP package, as per Annex "A" – Source List Questionnaire.
- 3.2 In order for a bid to be considered responsive, the bidder shall:
 - 3.2.1 Complete Part 1 of the Source List Questionnaire in full by populating all cells; and
 - 3.2.2 Complete at least one row of the table in Part 2 of the Source List Questionnaire. A complete row is defined as the following:
 - At least one (1) class of vehicle is selected (can be marked with an "X") for at least one (1) of the Embassy locations listed; and
 - An address of an authorized warranty approved full-service and parts location is provided in the last column; the location must be within 25 km of the Embassy for the selected vehicle class(es) and locations.
- 3.3 The DFATD evaluation team reserves the right, but is not obligated, to seek clarification or verify any or all information provided by the Bidder with respect to this solicitation.

SECTION "II" – GENERAL INSTRUCTIONS

GI1. RESPONSIVENESS

- 1.1** For a proposal to be considered valid, it must comply with all the requirements of this RFP identified as mandatory. Mandatory criteria are also expressed by using imperative verbs such as "shall", "must" and "will".

GI2. STANDARD INSTRUCTIONS, CLAUSES AND CONDITIONS

GI3. ENQUIRIES – SOLICITATION STAGE

- 3.1** All enquiries or issues concerning this procurement must be submitted in writing to the Contracting Authority as early as possible within the bidding period. Enquiries and issues must be received by the Contracting Authority no later than five (5) calendar days prior to the bid closing date specified herein to allow sufficient time to provide a response. Enquiries received after that time may not be answered.

To ensure consistency and quality of information provided to Proponents, the Contracting Authority will give notice simultaneously and in the same manner as this RFP, of any additional information in response to significant enquiries received, without revealing the source(s) of the enquiries.

All enquiries and other communications with government officials throughout the solicitation period shall be directed ONLY to the Contracting Authority. Non-compliance with this condition during the solicitation period may (for that reason alone) result in disqualification of your proposal.

GI4. PROPONENT'S SUGGESTED IMPROVEMENTS DURING SOLICITATION PERIOD

- 4.1** Should any Proponent consider that the specifications or Statement of Work contained in this RFP can be improved technically or technologically, the Proponent is invited to make suggestions, in writing, to the Contracting Authority named herein. - The vehicle must conform to all applicable laws, regulations and industry standards governing manufacture, safety, noise levels and pollution in effect in the region of delivery, for example, European Union, at time of manufacture, this will be specified in Phase 2 of 2; and
- The vehicle must include all components, and accessories normally supplied for the intended equipment Variant application, although they may not be specifically described in the Purchase Description.

Suppliers **are not** required to provide vehicles for all locations or for all vehicle classes in each location to be considered.
