This Amendment 003 (Addendum No. 3) is raised to amend the Request for Standing Offer (RFSO) document, and to provide clarifications to questions received.

On Page 2 of RFSO document, under SUPPLEMENTARY INSTRUCTIONS TO PROPONENTS (SI);

ADD: SI 2 FEDERAL CONTRACTORS PROGRAM FOR EMPLOYMENT EQUITY - CERTIFICATION
SI 3 SECURITY REQUIREMENTS

On Page 3 of RFSO document,

ADD:

SI 2 FEDERAL CONTRACTORS PROGRAM FOR EMPLOYMENT EQUITY - CERTIFICATION

By submitting a proposal, the Proponent certifies that the Proponent, and any of the Proponent's members if the Proponent is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list (<http://www.hrsdc.gc.ca/eng/labour/index.shtml>) available from [HRSDC-Labour's website](#).

Canada will have the right to declare a proposal non-responsive, or to set-aside a Standing Offer, if the Proponent, or any member of the Proponent if the Proponent is a Joint Venture, appears on the "[FCP Limited Eligibility to Bid](#)" list at the time of issuing of a Standing Offer or during the period of the Standing Offer.

SI 3 SECURITY REQUIREMENTS

Proponents are hereby informed that there is a strong possibility that some call-ups against the Standing Offers might require that the consultants and their personnel possesses a Facility Security Clearance (FSC) at the SECRET level issued by the Canadian Industrial Security Directorate (CISD) of Public Works and Government Services Canada (PWGSC).

Should the successful proponents not have the level of security indicated above, PWGSC shall sponsor the successful proponents so CISD can initiate procedures for security clearance. CISD, by letter, shall forward documentation to the successful proponents for completion.

Proponents desiring such sponsorship should so indicate in their covering letter with their proposal.

Successful proponent(s) issued a standing offer as a result of this RFSO, not possessing the required security clearance at time of call up, will be bypassed and PWGSC will proceed to the next consultant who possesses the required security clearance and it is furthest away from the ideal business distribution. Refer to the Standing Offer Particulars for information regarding ideal business distribution.

Q & A

Q1.) Can a small portion of the required services be performed by sub-consultant specialists?

A1.) The required services does not specify sub consultant services- if specialist is to be included in CV evaluation- the specialist's qualification need to be provided and will be considered as part of senior personnel for weight evaluation

Q2.) Are two (2) senior personnel and two (2) project personnel, the maximum number of individuals that we can include in the response?

A2.) Proponent can provide more than two, but only two will be evaluated and needed to be identified for evaluation.

Q3.) Please refer to section SRE of the Request for Standing Offer (RFSO); page 55 of 72; article 3.2.4 Senior Personnel Expertise and Experience; item 3.2.4.3. Please refer to excerpt below:

“In-house personnel means personnel within the Proponent's organization (see definition of Proponent in General Instructions GI 20). Past expertise and experience of personnel not within the Proponent's (or joint venture Proponent's) organization will not be considered in the evaluation.”

Please clarify the meaning of the second sentence. A senior engineer has recently joined our firm as a regular employee. Will his past experience with his previous employer be considered in the evaluation?

A3.) Item 3.2.4.3 is looking for long term senior employee in the firm. For recently joint senior personnel, his information can be listed under item 3.2.5 for Project Personnel for evaluation.
