**SPECIFICATIONS - QUESTIONS AND ANSWERS (numbering is continued from Amendment #1):**Question 5

What is the volume of the stockpile and can it be used for backfill?

Answer 5

The volume of the stockpile is currently unknown. It consists of material that was removed from the Western Land Treatment Facility (LTF) which has a dimension of 100 m X 30 m. As per Section 01 11 00, 1.3.1.8, it is currently expected that stockpiled material, once sorted from debris (see Photograph 3 in Appendix 4 - Inuvik FFTA Reconnaissance Summary Letter, SLR Consulting (Canada) Ltd, June 6, 2013) will be returned to the area of the Western LTF and evenly spread throughout.

Question 6

Are there any bore hole logs?

Answer 6

Significant background information about the site, including borehole logs, are contained in the Appendices, particularly Appendix 2: Phase III ESA, Pottinger Gaherty Environmental Consultants, February 2010.

Question 7

What is the depth of the dig?

Answer 7

The maximum depth of contamination identified in Appendix 2: Phase III ESA, Pottinger Gaherty Environmental Consultants, February 2010 was 3.0 m however the final extent of remediation will be determined based on visual observations, field vapour measurements and the results of the preliminary confirmatory sampling results.

Question 8

How many cubic meters of soil are in the stockpile?

Answer 8

See answer to question 5 (above).

Question 9

What is the distance to the borrow?

Answer 9

As outlined in Amendment #1- Question/Answer 1, the borrow source is located less than 1 km from the excavation site. The Location Plan included in the tender documents shows the location of the borrow source and Fire Training Area.

Question 10

What is the placement methodology?

Answer #10

Contaminated soil must be placed in the Eastern Land Treatment Facility (LTF) in such a manner to not damage the geomembrane and geotextile and is subject to the on-site approval of the Departmental Representative.

What are the dimensions of the LTF?

Answer 11

The dimension of the Eastern Land Treatment Facility is 30 m by 80 m.

Question 12

What are the Specifications for the berm and sump design?

Answer 12

No berm alterations are required. The grading and sump design are as shown on the attached drawing (C4).

Question 13

Is all the debris mentioned in 4.2.5.3 located in the stockpile

Answer 13

Arctic liner material is interspersed within the stockpiled soil and within the berm around the western Land Treatment facility (see Photographs 2 and 3 in Appendix 4 - Inuvik FFTA Reconnaissance Summary Letter, SLR Consulting (Canada) Ltd, June 6, 2013).
