### RE: Addendum #1

Delete Answer A1 and Replace with following:

A1: All accommodation, hotel and motel costs will not be paid while working in the headquarters area, defined as the project location.

### The following are new questions and answers:

Q1: Are costs associated with daily meals included in the Disbursements & Disposables, and if yes, would it be at Government of Canada Daily Allowance or by receipt?

A1: All classes of personnel required in Annex "B" will not be paid travel cost while working in the headquarters area, defined as the project location.
