Collect waste and dispose offsite. Immediately, ground conditions permitting, de-thatch grassed areas using an accepted de-thatching/ combing machine and collect all accumulations to dispose offsite. Areas A, E, 1, 2 ,3 and 7(see attached site drawing) “.

"DESCRIPTION OF WORK

- (1) SPRING CLEANUP: In Areas A, E, 1, 2 ,3 and 7(see attached site drawing) = Rake lawn areas, to loosen matted grass and remove dead vegetation, leaves, stones, paper, salt and sand and other debris accumulated over the winter months. Collect waste and dispose offsite.
In Areas E, 1, 2 ,3 and 7 only = immediately the ground conditions permit; de-thatch grassed areas using an accepted de-thatching/ combing machine and collect all accumulations to dispose offsite.”
