Answer 4

The National Capital Region is not excluded from this Request for Standing Offers (RFSO). As shown in Annex F, the National Capital Region is considered a sub-region.

As defined at page 5 of 75, a sub-region is:

"a smaller area within a Region as subdivided in Annex F in which the Offeror can propose firm hourly rates including travel and living costs."
