Solicitation Amendment No. 5

This solicitation is hereby amended to provide the following questions and answers

Q1. The first is in reference to 7.1.1 Travel and Living Expenses

It states that the contractor will be reimbursed for its authorized travel and living expenses. Does this mean that the teachers and instructors hired will be reimbursed for mileage to and from Renous on a day to day basis? The majority of our teachers will be commuting from Miramichi which is approximately 37km from the teaching location. The RFP states that the estimated cost is \$1,000 and this would not cover the travel cost for 125 days of travel for 4 different people. Can you clarify travel expenses?

A1. This refers to a situation where "Contract personnel may be required to travel on behalf of the Correctional Service of Canada." For example, if they are asked to participate in a meeting in Moncton, their pre-approved travel expenses would be reimbursed as per Treasury Board Policy. This does NOT mean that they will be reimbursed for their commuting expenses to and from the institution.

Q2. Is the curriculum that will be taught already prepared or would the successful bidder be required to create the curriculum?

A2. The curriculum is already prepared.
